

## May 3<sup>rd</sup>, 2021 Jersey Township Trustees Monthly Meeting

The meeting was called to order and the Pledge of Allegiance was given. Trustees Wetzel, Bright and Fry, Fiscal Officer Jesenko, and Zoning Inspector Witney were all present for the meeting. The minutes for the April 5<sup>th</sup> Monthly Meeting and the April 19<sup>th</sup> Special Meeting were read aloud by the fiscal officer. Trustee Bright moved to accept the minutes as read; Trustee Fry seconded the motion. Vote: Wetzel- yes, Bright- yes, Fry- yes.

Zoning Report- proposed definition to be added to zoning code; a battery storage container or cabinet shall be defined as an enclosure for racks of batteries which may also include related systems such as fire suppression, HVAC, et cetera. Trustee Wetzel moved to accept the definition as read; Trustee Bright seconded the motion. Vote: Wetzel- yes, Bright- yes, Fry- yes. The Zoning Commission was working on further definitions based on recommendation from Licking County Planning.

Monroe Township Fire Department- no report.


South West Licking Fire District- ethics training in development.
